## **MEDICAL FORMS**

The USDA Meal Pattern is very important to follow. Meals that do not contain all the required components cannot be reimbursed. But what about those children that have food allergies or other medical issues that make it impossible to serve a requirement component?

ANSWER: Children in this category CAN be exempted form the normal requirements, but ONLY if they have a signed doctor's note stating clearly that there is a medical reason requiring the exemption.

PROBLEM: A common problem we have is that providers are submitting doctor's notes supplied by the parents that do not contain the necessary information to qualify as an exemption. A note stating the child has "a medical problem" without specifically stating how it affects the meals served is not enough to satisfy the USDA guidelines.

SOLUTION: The State has provided a form to use that is designed for the parent to take to the child's doctor. The doctor simply needs to fill out the form and sign it for the parent, who can then give it to the provider. Once we receive that form here in the office, we can allow the provider to claim the meal without serving the exempted component to that child.



### REMINDER

School is coming up soon! Be sure to check the enrollments for meals served to any children that will be starting school in September. If the child will be present for meals that he was not previously enrolled in, be sure to have the parents fill out a new enrollment. By doing this in advance you will be sure to be approved for the full reimbursement due to you!

## TRAININGS

Once again we want to remind you to be sure to complete all 3 trainings for this year before September. It is VERY important that you be sure to do so in order to be able to claim for the month of September.

Any provider who does not complete all 6 hours of training by the end of September is at risk of being Seriously Deficient and may be disallowed for the entire month of September! We don't want to see that happen to you!
